



AMENDMENT NO. [2] TO [STATEMENT OF WORK NO.3]

This Amendment No. 2 to Statement Of Work No. 3 (“**Amendment**”) is made as of this October 24, 2023, by and between **CPESN USA, LLC**. A North Carolina limited liability company (“**Supplier**”) and **WellCare of North Carolina, Inc** an affiliate of Centene Management Company, LLC, a Wisconsin limited liability company (“**Centene**”) with reference to the following facts:

1. Supplier and Centene entered into a Masters Service Agreement dated June 14, 2022,
2. Supplier and Centene intend to extend the agreement.
3. In this Amendment, the parties desire to extend agreement.

Now therefore, in consideration of the mutual promises, covenants, agreements and other undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree for the Agreement to be amended as follows:

Section 1.

Section **VII. SOW TERM** of the Agreement is deleted in its entirety and replaced with the following:

The Services described in this Amendment shall begin on **October 31, 2023** and continue until **October 31, 2024** (the "Initial Term"). Upon the expiration of the Initial Term, WellCare shall have the right to renew the Statement of Work at the fees listed, for consecutive Renewal Terms of twelve (12) months each, not to exceed a maximum of three (3) year Renewal Terms, by providing Vendor written notice of renewal at least thirty, (30) days prior to the expiration of the then-current term.

Except as amended and modified by this Amendment, all of the terms and conditions of the Agreement shall remain in full force and effect. This Amendment may not be modified except in writing signed by both parties hereto. This Amendment, the Agreement, together with its attachments, as previously amended in each case, constitute the entire agreement of the parties with respect to the subject matter contained therein and supersede any and all prior or contemporaneous agreements between the parties, whether oral or written, concerning the subject matter contained herein.
